

## **GIVING FROM AN IRA**

IRA owners age 70  $\frac{1}{2}$  or over can make tax-free gifts directly from an IRA to InterVarsity. Each IRA owner can transfer up to a total of \$105,000 tax-free per year directly from his or her IRA to InterVarsity and other charities with a Qualified Charitable Distribution (QCD).

#### **Benefits**

- QCDs are excluded from taxable income (therefore offer the same benefits as an itemized income tax charitable deduction).
- If you are taking a Required Minimum Distribution (RMD), QCDs will count toward satisfying your RMD without increasing your taxable income.
- Your gift supports the important work of InterVarsity.

### How to Make a Qualified Charitable Distribution to InterVarsity

- Contact your IRA custodian/administrator for their procedures. Tell them you
  want to initiate a Qualified Charitable Distribution directly to InterVarsity
  Christian Fellowship, P.O. Box 7895, Madison WI 53707-7895.
- 2. To assure that your gift is credited to you and applied to the specific InterVarsity ministry/ies you want it to support, be sure to notify us of these details by completing and mailing the enclosed letter, or by calling our Donor Services Department (toll-free 866-734-4823).

# Important Tax Considerations When Making a Qualified Charitable Distribution

- For tax purposes, the date of the gift is the date the funds leave your IRA account, not the postmark on the envelope.
- If you will be writing a check to InterVarsity from a checkbook provided by your IRA custodian, mail your check to us no later than December 1.
- It is important to check with your tax advisor before making a QCD.
